

**DISTRICT OF HIGHLANDS
BYLAW NO. 289**

A Bylaw to Provide for Fees and Charges Payable for Services and Facilities to the
West Shore Parks and Recreation Society

WHEREAS the District established a service for parks, recreation and community services pursuant to the Parks, Recreation and Community Service Establishment Bylaw No. 170, 2001;

AND WHEREAS pursuant to section 363 of the *Local Government Act*, Council may, by bylaw, impose a fee or charge payable in respect of all or part of a service of the municipality or the exercise of regulatory authority by the municipality;

AND WHEREAS Council wishes to authorize and impose the fees and charges payable for use of the services and facilities at the Juan de Fuca Recreation Centre, which fees and charges must also be authorized by the other local government owners of the Juan de Fuca Recreation Centre;

NOW THEREFORE the Council of the District of Highlands, in open meeting assembled, enacts as follows:

1. Title

This Bylaw may be cited for all purposes as the "West Shore Parks and Recreation Society Fees and Charges Bylaw No. 289, 2006".

2. Imposition of Fees and Charges

That Schedule "A" to the Juan de Fuca Recreation Centre Fees and Charges Bylaw No. 273 is deleted and replaced with the attached Schedule "A" to this Bylaw.

That Council hereby authorizes and imposes the fees and charges for use of the services and facilities at the West Shore Parks and Recreation Society in the amounts set out in Schedule "A" to this Bylaw.

3. Rescind

Rescind "Juan de Fuca Recreation Centre Fees and Charges Amendment Bylaw No. 273" in its entirety and replace with "West Shore Parks and Recreation Society Fees and Charges Bylaw No. 289, 2006".

The fees and charges established under this Bylaw shall come into effect on September 1, 2006 and continue until August 31, 2007.
