2. <u>PETITIONS AND DELEGATIONS</u>

Dave Mackas, Caleb Pike Road addressed Council to discuss item 8b) on the agenda regarding Minister Polak's letter regarding the Esquimalt Graving Dock Project and the Tervita Landfill site. Mr. Mackas discussed various issues discussed in the letter including: the Minister acknowledging the serious concerns of the residents of Highlands which is why there has been a request of an independent assessment of the risks associated with this project; the actions offered by the Minister do not provide the residents of the Highlands the same confidence that an independent assessment would; and the short comings of the current Design and Operations Plan for the Tervita site. He supports a cost sharing agreement between federal, provincial and the district for an independent review.

Eric Bonham addressed Council and thanked Council for their decision to support the grant in aid request from the Goldstream Neighbourhood House.

Mr. Bonham also addressed Council regarding item 8b) on the agenda regarding Minister Polak's letter regarding the Esquimalt Graving Dock Project and the Tervita Landfill site. He thanked Council for meeting with the Minister and expressing the concerns of Highlands's residents. Mr. Bonham feels that the ministry is falling short regarding an independent review of the Tervita site and feels that the current process excludes the interests and concerns of the people most affected should contamination occur.

He supports a cost sharing agreement between federal, provincial and the district for the independent review.

Bob McMinn, Millstream Lake Road, addressed Council regarding a meeting that took place on Monday, January 20, 2014 with the local MP, Randall Garrison and MLA, John Horgan and the Highlands Residents' for Clean Water Group. The question was asked to both the MP and MLA whether they would undertake actions to determine whether depositing contaminated waste at the Tervita site is putting Highlands's ground water at risk over the long term. The Highland Residents' for Clean Water Group is seeking funding from the local, provincial and federal government to obtain an independent review of the Tervita site. This group believes it is the only way to determine if the current method does or does not protect the quality of Highlands's groundwater over the long term. They are asking Council to recognize that a financial commitment is necessary.

Val Fletcher addressed Council regarding item 8b) on the agenda regarding Minister Polak's letter regarding the Esquimalt Graving Dock Project and the Tervita Landfill site. He encouraged Council to require an independent assessment of the Tervita site. Mr. Fletcher referred to a discussion paper produced by G. Fred Lee which discusses possible and/ or probable failures in landfill liners. Mr. Fletcher had personally discussed landfill liner failure with Mr. Lee and the following three points were advised:

- 1. Have a site specific hydrogeological study done that would show a pathway (via fractured rock) of contaminants into the aquifer once the liner fails
- Document the (probable) failure of landfill liners over time. (e.g. "Flawed Technology of Subtitle D Landfilling of Municipal Solid Waste" G. Fred Lee and Associations)
- 3. Document all the potentially leachable components of the contaminated waste being landfilled at the site.
