

#### SUCCESS, NOT QUITE AT THE SPEED OF LIGHT...

In August, 2005, Highlands Council voted to install a streetlight on Millstream Road across from Stewart Mountain Road. The resolution included specification of a 'flat glass downcast luminary, a type recommended by Highlands resident and astronomer Sid Sidhu. The streetlight was installed, but was fitted with an older style lamp that cast light out as well as down. It took patience and perseverance, but last week, Hydro



replaced the fixture with a flat glass or full cutoff style. A Google search demonstrates that this type of fixture has become an increasingly common standard. As streetlights in Highlands require maintenance, the hardware will be updated. Next time you pass by Stewart Mountain Road, stop and take a look and then compare it to the older style lamps. For energy savings, reduced light pollution, preservation of our night sky and targeting light where it is wanted, this is a definite improvement.

IN MEMORY Long-time Highlands roads consultant (James) Bruce Robertson of JBR Consulting passed away on October 10th. Highlanders will remember Bruce from the many roads walks over the years with Council, staff and residents, to determine how Highlands roads should be upgraded. 
## Community News

FIREWORKS BYLAW AMENDMENT (Bylaw 320) In the spring of 2007 Council adopted a fireworks bylaw to coincide with bylaws passed by Colwood, Langford and View Royal. A key component of the bylaw was a requirement for a permit for the discharge of consumer fireworks. The applicant was required to complete either the Fireworks Supervisor Level 1 or Level 2 training conducted by the Explosives Regulatory Division of Natural Resources Canada, and show proof prior to obtaining a permit. Since NRC training is primarily designed for industry professions and is not easily or quickly obtained. Council has adopted an amendment to the bylaw allowing a permit to be issued to applicants who have completed a seminar or other instruction offered by a fire department within the CRD.

If you are considering setting off fireworks within the District, there are other restrictions within Bylaw 254 that you should know about. Please visit the District website or contact the office for details, 250-474-1773.

UPCOMING LANDFILL BANS The CRD is considering banning two additional materials, wood waste and product stewardship items, from Hartland Landfill commencing

GOLDSTREAM FOOD BANK The volunteers at the Goldstream Food Bank Society, (all are unpaid volunteers), report an increase in their clientele. Many families are experiencing difficult times this fall, and the Society is requesting assistance from those able to donate at this time. The Food Bank runs until the end of November, at which time it becomes the Christmas Hamper Fund for the month of December. To add to the challenge, the Society's van needs immediate replacement. SEASONAL SAFETY REMINDERS As fall progresses, a reminder to residents to test all smoke alarms and change the batteries. The provincial government recently released a bulletin regarding fire safety that advises smoke alarms be replaced after 5-10 years. It can be found here: http://tinyurl.com/yja7vlr

Check to see if your address sign is clearly legible and visible from the road, especially at night.

Lastly, members of the Highlands Volunteer Fire Department encourage residents to clean chimneys regularly, and advise us not to burn paper or refuse in our fireplaces or woodstoves as can increase the risk of a chimney fire. It is wise to avoid burning unseasoned wood, as it can contribute to creosote formation.

RECYCLING BIN NO LONGER AT RED BARN MARKET The CRD maintained a recycling bin at the Red Barn Market on West Saanich Road for many years. The bin was for the benefit of Ross-Durrance Road residents who did not have Blue Box pick up in the distant past. Roadside pick up has occurred in recent times, however the bin remained in place until a few weeks ago. Although used by residents throughout the region, due to some unfortunate incidents of non-recyclable materials being placed in the bin, it has been removed.

There is a flat-fee user pay recycling area located at Hartland Landfill that is open to all residents of the region. ### Council & District News

REGIONAL CONTEXT STATEMENT Each CRD municipality must include within their Official Community Plan (OCP) a Regional Context Statement (RCS) which states how the municipality will comply with the Regional Growth Strategy (RGS). The RGS was amended by arbitration in January 2009 to include portions of the Bear Mountain property within the Urban Containment Boundary in order to allow piped services in those portions. That amendment makes the current Highlands RCS inconsistent, and Council has taken steps to update this in the Highlands OCP.

Council has directed staff to submit the proposed RCS to the CRD board for acceptance, and to neighbouring municipal Councils, First Nations, school boards, and to the province's Intergovernmental Relations and Planning Division for consultation. If accepted by the board, Council will initiate an OCP amendment to include the new Regional Context State-

UBCM CONVENTION Four Highlands Council members attended this year's UBCM convention, held in Vancouver recently. Highlights of the convention included a session on HST, working with First Nations, and various topics related to sustainable planning and the provincial Climate Action Charter. These sessions provide a wealth of up-to-date information that will be helpful to Council in its future planning and decision-making. The District attended meetings with the following Ministers and their senior staff: Minister Abbott, Aboriginal Relations and Reconciliation (regarding future land use of crown properties in the District); Minister Penner, Environment (requesting funds for bullfrog control and a follow up on groundwater protection), and Minister Thomson, Agriculture and Lands, (regarding future use of contaminated lands). Council looks forward to working with the various ministries on issues of importance to the District.

COMMUNITY HALL UPDATE Council and the Community Centre Task Force are working toward implementing public consultation regarding the topic of a community hall. At the October 13<sup>th</sup> Committee of the Whole meeting, Council and the task force discussed essential elements that would be beneficial to include in a community hall and the merits of hiring a consultant to perform cost estimates. Council is mindful that a decision on whether to proceed will need to be made early in 2010 in order to meet the requirements of the grant funding.

Watch for an upcoming opportunity to review the work to date and to express your views.

REQUEST FROM WSPRS At the October 19<sup>th</sup> meeting, Council considered a request from the Westshore Parks and Recreation Society (WSPRS) regarding approval in principle to explore the potential siting of a sewage treatment plant on the jointly-owned Juan de Fuca property.

Council provided in principle approval to explore options accompanied by conditions that included: associated with exploration of options to be borne by Colwood and Langford (the main users of a potential utility); the proposed utility be of benefit to both the recreation facility and the neighbouring municipalities with regard to resource recovery; and that any reports and agreements be forwarded to the co-owners for review and approval.

Since Council's deliberations, it has been identified that a letter of approval may be needed to accompany a grant application being coordinated by the CRD; Council anticipates revisiting this topic in the near future.

MILLSTREAM MEADOWS UPDATE A contract to infill the previously excavated portion of Millstream Meadows has been awarded by the CRD to Aggressive Excavating. The work is scheduled to begin soon, so watch for additional truck traffic in the lower Millstream Road area. The remaining soil in the contaminated area has been characterized. A report based on the test results is expected at CRD Environment committee in the near future.
