 BC Hydro presentation: update on supply/demand forecasting and electrificationmandates.

- Increased supply required due to growth of population and increased electrification of the energy usage (ie EV's, heat pumps, and more A/C etc).
  - Electricity demand increasing by <u>at least</u> 15% by 2030
- Site C will add 8%
- Call for power to generate 5% (including grants for roof top solar and battery storage)
- The rest through efficiency (including time of day billing)
- Droughts are impacting hydro power
- Interesting that five years back Mayor Williams and I met with both the Minister and BC Hydro to discuss the need for solar to meet the increased electrical demand. We were told there was no need for solar.

Attended the July monthly meeting of the Local Leadership United (LLU). "Local Leadership United (LLU) is a provincial project delivered through a partnership between Community Action Initiative (CAI) and the BC Centre for Disease Control

(BCCDC). It aims to support local governments, particularly elected officials, with the work communities are already doing to respond to the overdose/toxic drug/drug poisoning crisis. The project was created in recognition that municipalities are uniquely positioned to support overdose response through their local expertise. Specifically, LLU is supporting local elected officials and other stakeholders, by hosting regional convenings across the province."

#### Wed. June 19th CRD Environmental Services Committee

I attended the ESC Committee meeting to discuss agenda item 6.1, which proposed an additional \$620,000 for the Millstream Meadows remediation budget to complete key deliverables. The CRD aims to apply for a Certificate of Compliance by the end of 2024, with risk-based certificates expected from the Ministry of Environment and Climate Strategy in early 2025. I wanted to clarify to the committee that the current land use is designated as Greenbelt 2 and that we are in the process of updating our Official Community Plan, which may result in changes to allowable land use.

#### Wed. June 26th CRD Regional Parks Committee

The Parks Committee recommended to the CRD Board that: Current service levels be maintained, focusing on continued public education to address water safety in regional parks, and that staff work with partners to increase education and awareness for key demographic groups. Also, the committee approved that a pilot project

The Committee also recommended to the CRD Board that there be a comprehensive study on the safety of multi-use trails due to the recent increase of accidents.

The South Island Division of Family Practice invited Westshore mayors and stakeholders to the Songhees Wellness Centre to request support for attracting healthcare and emergency workers to our area. This event was sponsored by the Saunders Family Foundation.
