Over the past few months, Highlands has said goodbye to two extraordinary residents whose contributions helped shape the heart and spirit of our community — Allan Roger and Sid Sidhu.

Though their passions were different, both embodied what it means to give generously, joyfully, and wholeheartedly to the place they called home.

**Allan Roger** was a man who believed in showing up — for his neighbours, for his community, and for the future. As a volunteer firefighter and chair of the Sustainable Land Use Select Committee, he worked tirelessly to keep residents safe and to help guide decisions that will shape Highlands for generations. Many will remember him as Santa on the Santa Run, and as the warm, witty MC of the Highland Fling, where his energy made every gathering feel like a family celebration. Allan's spirit of service, kindness, and joy will continue to echo in every corner of community life.

**Jaskarn 'Sid' Singh Sidhu** shared a different kind of light — one that came from the night sky. For nearly forty years, he inspired thousands of children and adults with his passion for astronomy. Whether giving school presentations, lending telescopes through the Victoria Centre, or welcoming neighbours to his backyard observatory, Sid brought the wonders of the universe within reach. The asteroid named in his honour is a fitting tribute to a man whose gentle spirit and curiosity touched so many. His legacy will live on in every young person who looks up and feels that first spark of awe.

To the families of Allan and Sid, the District of Highlands extends its deepest condolences and heartfelt thanks. We are grateful for all they shared with us — their time, their talents, and the unique joy each brought to our community. Their memories will continue to shine, here on the ground and in the skies above.

## New Parks Management Bylaw

The District of Highlands is taking important steps to safeguard our natural spaces. Council has recently adopted the “Parks Management Bylaw No. 470, 2025”, which applies to all parks, beaches, and public open spaces within the District. This bylaw strengthens protections for environmentally sensitive areas and ensures that our parks remain safe and enjoyable for everyone.

Under the new regulations, use of all-terrain vehicles (ATVs), motorcycles, and other motorised vehicles within parks are prohibited. Horse access to parks is only allowed in areas expressly designed for equestrian use. These measures are designed to minimise damage to trails and sensitive ecosystems, reduce erosion, protect wildlife habitats, and maintain the natural beauty of our parks. If you're planning a special event, commercial or business activity, or any activity that goes beyond everyday park use, the Parks Management Bylaw requires you to obtain a permit. Please reach out to the District office for more information.

## Eagles Lake Park

Restoration work is underway at Eagles Lake Park following the removal of a hazardous tree near the beach access. This project reflects our commitment to visitor safety and ecological integrity. The restoration includes stabilising disturbed areas and enhancing native vegetation to support biodiversity.

We encourage all visitors to respect these rules and help us preserve the Highlands' unique landscapes for future generations. Together, we can ensure that our parks remain a sanctuary for people and wildlife alike.



## Highlands After Dark: Lighting Restrictions Support Highlands' Natural Character

To help maintain Highlands' rural character and protect our night skies, the District has introduced updated lighting regulations through the Zoning Bylaw. These new rules are designed to minimize light pollution, ensuring outdoor lighting is used thoughtfully and only where truly needed. Highlights of the new regulations include:

- No flashing or blinking exterior lighting is permitted anywhere in the District.
- All direct and ambient lighting in residential zones must be shielded so that light does not shine beyond the boundaries of the property.
- Lighting posts may not exceed the lesser of the height of the primary building or 7.0 metres.

By following these guidelines, residents can help preserve the natural beauty and tranquillity of Highlands after dark, keeping our community a welcoming place for people and wildlife alike.

## Outdoor Burning

There is no longer an open season for burning so permits are now required for all outdoor burning. Permits are free and can be obtained online at: <https://hvf.d.burnpermits.com/>. Burning in woodstoves does not require a permit. ## Exciting News for Electric Vehicle Users

The District of Highlands is pleased to announce the upcoming installation of the two new Level 2 electric vehicle charging stations at the Community Hall.

### Key Details:

- **Location:** Highlands Community Hall, 729 Finlayson Arm Road
- **Type:** Level 2 charging stations, suitable for most electric vehicles
- **Access:** Available to residents and visitors, with a modest user fee

### How It Works:

The District has entered into a licence of occupation agreement with the Capital Regional District, allowing the chargers to be installed and operated on municipal land. This agreement outlines responsibilities for maintenance, service, and fee collection, ensuring reliable access for all users. The chargers are part of a regional network, making it easier to travel sustainably throughout the Capital Region.

**Why It Matters:** This project supports Highlands' commitment to climate action and sustainable transportation. By providing convenient charging options, the District encourages residents and visitors to choose low-emission vehicles and helps reduce our community's carbon footprint.
